The trends of employees of the Supreme Council for youth forward novelty and its impacts on the

social, economic and political life of youth

Abstract

This study aimed for realizing the trends of employees of the Supreme Council for youth forward novelty and its impacts on the social, economic and political life of youth. It was applied on (1110) employees, "185" of whom were selected randomly to fill the study application. The mechanism of such study was prepared and submitted to a number of arbitrators specialized in this domain, and the reliability of it was calculated be the repetition method to reach 0.85.

The Study resulted that there are clear impacts of globalization on youth in Jordan, represented in the increase of individualism of the expense of pluralism and in the wide spread unemployment among youth. In addition, the impact of novelty was negative on the adherence of south to social traditions and customs. The study also showed that there are no differences in the trends of employees of the Supreme council for youth toward novelty, that its impacts are attributed to sex and accommodation and that there are no differences of statistical connotation attributed to academic qualifications and work experiences.

The study recommended the necessity of finding means and ways to deal with youth in correspondence with the new reality and in a way maintaining social tradition and customs as well as the society and its entity, without affecting the economic, social and political freedom of the individual.

Furthermore, modernity also extended to other aspects of human life, what is witnessed of democracy, including the participation of all the people in power at different positions according to various democratic forms and by what people see in their own country and determine all matters relating to the lives of themselves and bear the consequences of their decisions to the social dissatisfaction stage on all matters of life is one of the most prominent results of modernity.

Wilson and Werner (1980) show in their study about the views of globalization and education, the study found having difficulty with social curriculum teacher explain world events for students and thus their inability to understand world events. Moreover, Remey (1992) study on the topic of globalization and education, which referred its findings to the students should participate within their home and change within their own country to become in line with global events. Also, Wheeler (2000) conducted a study related to the media and globalization Kuwaiti national identity the study concluded that it should use the students to the Internet with control over this use. In addition Barbara (2000) conducted a stud on US studies on social issues in the atheist and the twentieth century the study found that there is a single view by Americans to the world. They see that there is no culture or the dominance of other non-American in this world. the Arab world not in isolation from these studies and research has indicated that the results of the study carried out by Toukhi (1993) about the relationship between education and national security, and between globalization and the revolution of knowledge to the impact of globalization various financial and food, medical and education fields and military fields and environmental Affairs in addition to the impact of globalization on the behavior and the new concepts of facts and values, customs and traditions. Moreover, Abdul Karim (1997) in a study related to the ability of Arab countries to stand up to the royal states of the possibilities that the Arab countries is able to stand in front of variables before the Arab business arena. While Owaidat (2001) referred that learning is the basis of the conservation entity of the nation and its composition, Abdullah (1999) stressed on the need for attention to Arabic and raising identity and deepening of belonging and social responsibility and to prepare for life and creativity, cohesion and scientific research and education for the challenges of globalization. However, Bashta (2002) confirmed to to keep religion and moral far away from extremism, as well as the teaching of morality because that would cope with globalization and the various dimensions of human such as anxiety and balance of society and the happiness of humankind.

This study is trying to answer the main question which stated:

"What is the trends of employees of the Supreme Council for youth forward novelty and its impacts on the social, economic and political life of youth?"

Which is divided by the following sub-questions:

1. What is the trends of employees of the Supreme Council for youth forward novelty and its impacts on the social, economic and political life

of youth according to the gender?

The importance of this study come from the following points:

• The target group in this study is the category that deals with young people directly and has the makings of experience because the trends

are towards modernity and its impact on young people accurate directions.

Study Model




Figure 1: Shows the Study Model

Table (5) show that there are significant differences between the qualification and in favor of post-graduation educational qualification. Moreover, there were no statistically significant differences between the graduate category, bachelor and diploma. The results also indicate that there are significant differences depending on the experience and class between 5 years and 10-15 years category and in favor of a class of 5 years.

Conclusions and recommendations

Discuss the results of the main question, which sated "What is the trends of employees of the Supreme Council for youth forward novelty and its impacts on the social, economic and political life of youth?" The results indicate that the paragraph "Individual increase on the group's account" with mean (4.24), however, it's a high degree and perhaps this indicates to increased freedoms among members of Jordanian society and reduction of the patriarchal and tribal power has led to increased individual motivation between individuals and the interest of the person himself greater degree of interest in others. Moreover, the paragraph which states" Unemployment between youth increase significantly" came in second place with mean (4.22) it's also a high degree and This may be due to the vulnerability to the global economy, the strength of industrial companies and capital have made the local companies weak as well as increasing of relying on imports, particularly in the commodity era of electronics in all its forms has made the chance of young people in the weakest labor has also been attributed to the high literacy rate resulting from educational technology and education at the post as if he forms of education and increase university preparation has led to the desire of young people to work in the office and administrative areas, which increased the rate of unemployment among young people. Furthermore, the paragraph (Young people clings on the social traditions.) came in last place and with a mean of \$(2.81) and moderate degree, however, this result may be due to the fact that various technological instrument, globalization tools like: satellite, computer and internet...etc., has made the young people live with these tools more than living with society members. Moreover, to inform young people on the customs and traditions of other societies may saturate the insider desires and motivations of the young people which tends to these new habits and gradually moving away from the community habits and affiliated to it are relatively weak.

Discuss the results of the first question, which satetd "What is the trends of employees of the Supreme Council for youth forward novelty and its impacts on the social, economic and political life of youth according to the gender? ". The study results appear that there is no statistically significant differences due to gender, the result attributed to the fact that males and females, especially employees of whom had walked side by side in education and earn a living in looking at their various modern life affairs in addition to doing the same work and the tasks entrusted to them has made their approach to the issue of globalization is no different from male to female.

The study results showed existence of significant differences attributable to the qualification between postgraduate and high school, the

differences due to the fact that postgraduate category was the perception to the subject at an angle of Higher Education standpoint of research

and study and objectivity in judgment. This study showed the existence of significant differences of experience variable and the category (Less

than 5 years) and category (From 11 years – 15 years) and in favor of a class (Less than 5 years), however, this result due to the fact that this

category any category (Less than 5 years) is the closest groups to young people in terms of age and therefore they have reversed its view CV to

itself may be that category affected by globalization more directly than other categories. The study results related to the place of residence

variable did not show a significant statistical differences, which indicates that globalization and communication instruments has reached and

affected all people, regardless of their place of residence and the same degree of level.

Discuss the results of the first question, which sated "What is the trends of employees of the Supreme Council for youth forward novelty and its impacts on the social, economic and political life of youth according to the qualification, residence and experience?"

Based on the study findings, this study recommends the need to find tools and methods to deal with young people in line with the new reality and so as to maintain social customs and traditions, and including also keeps the society and his being freely and without prejudice to the economic, social and political individual.
